Dear Lane County Commissioners,

Three years ago, The Oregon Department of Transportation (ODOT) notified the City of Florence of an upcoming grind and overlay project. What began as a simple re-paving of Highway 101, has transformed into a collaborative effort between the City of Florence and the Oregon Department of Transportation. ReVision Florence will transform Highway 101, improving safety and accessibility for all users of the corridor while creating an inviting multi-modal streetscape for the City's residents and visitors.

While improvements to US 101 began as a routine paving project, ReVision Florence has implemented elements of the City's Transportation System Plan that was adopted in 2010 and provides a 25 year plan for their transportation system. With the addition of gateways, public art, plazas, wider sidewalks, ADA accessibility, bicycle lanes, and other traffic calming techniques, this project enhances multi-modal transportation options along Highway 101, while simultaneously creating a more inviting, livable, and vibrant community. The City's efforts are in line with ODOT's Highway Plan and the Federal Highway Administration that have designated US 101 as both a state and national scenic byway.

In this current era it is rare to see such a large project in full swing, but ReVision Florence is breaking ground in the summer of 2018. The City of Florence and ODOT have planned the project delivery to minimize road construction impacts to businesses and residents during the short construction season that coincides with the peak tourism season. In addition, the City can undertake needed utility work ahead of the repaving so that the final product will be seamless.

State and federal funding was allocated to the Siuslaw River Bridge to upgrade the electrical system and to protect the bridge from corrosion and seismic upgrades. This project will be completed in the coming months. With completion of this important McCullough Bridge project, ODOT looks forward to this continued partnership with the City of Florence in their efforts to improve the streetscape and character along US 101; not only because of the substantial local impact, but because of its wider implications for Western Lane County and the state as a whole.



Transient Room Tax (TRT) in Lane County Oregon

Lane County and each city has the authority to levy transient room tax. TRT is collected from the region's 5,500 rooms that are distributed across hotels, motels, lodges, bed & breakfasts, Airbnb, and vacation rentals. Another 3,300 private, city, county, and state RV parks and campground sites are taxed.

In FY17, combined County and city TRT yielded \$11.6 million county-wide. The City of Eugene collects the tax for all cities and the County and distributes it back to each jurisdiction.


Lane County retains 5% of the receipts within cities that have triggered local TRT rate increases, while retaining the entire 8% throughout the remainder of the County. For example, within the City of Eugene the County retains 5% and the City of Eugene retains 4.5%. The following table outlines the TRT rates by jurisdiction and the time line at the bottom of the page illustrates when rates were increased.



In FY17, Travel Lane County was provided approximately \$2.6 million in TRT for the purposes of marketing the destination to three primary visitor markets. These markets include meetings and convention attendees, leisure travelers, and sporting event participants and fans.

Funding of destination marketing efforts through transient room taxes creates an entrepreneurial environment providing incentives for greater and greater success.

Travel Lane County staff strives to continually improve products and services to meet the changing needs of leisure, sports and convention travelers. As we succeed, room nights sold increase which increases transient room tax receipts resulting in increases in funding for future destination marketing efforts.
