RESOLUTION PC 24 27 PUD 01- Elm Park PUD & PC 24 28 SUB 01 Elm Park Replat:

The PUD proposal and replat applications consist of combining the 20 existing lots in Block 57 into three and forming a Planned Unit Development consisting of 32 affordable housing units and an early learning facility with associated parking, landscaping, stormwater management, open space, and recreation space. The proposal includes reduced setbacks, modifying buffering requirements, and establishing a preference for families earning up to 60% of the area median income. The development is proposed for 1.47 acres of property as shown on the Lane County Assessor's Map Ref 18-12-27-31, Tax Lots 01100 and 01200, located on near Greenwood St. between 10<sup>th</sup> and 11<sup>th</sup> Sts.

The development is proposed to be located northwest of the intersection of Greenwood and 10<sup>th</sup> Sts. as shown on the Lane County Assessor's Map Ref 18-12-27-31, Tax Lot 01100.
- 7. <u>RESOLUTION AR 24 04 DR 03 Apartments:</u> The Design review application consists of constructing 32 affordable housing units in 5 buildings with associated parking, landscaping, stormwater management, open space, and recreation space. The development is proposed to be located southwest of the intersection of the Greenwood and 11th Sts. as shown on the Lane County Assessor's Map Ref 18-12-27-31, Tax Lots 01100 and 01200.

(5) Provide verbal testimony at the hearing either in person or via GoToWebinar. If participating remotely please complete a speaker's card request in person or online at https://www.ci.florence.or.us/bc-pc/request-addressplanning-commission-speakers-card at least 1 hour prior to the meeting (January 28, 2025). #### Speaking time limits:

- Public Comments on items not on the agenda: General public comments (on items not on the Planning Commission agenda) will be allowed at each Planning Commission meeting during the public comment agenda item. Comments will be limited to three (3) minutes per person, with a maximum of 15 minutes for all items. In practicality, this means no more than five (5) individuals will be allowed to comment verbally. There is no limit on written public comments.
- 2. <u>Public Hearing Testimony</u>: Testimony on public hearing items will be allowed when a public hearing is held. Testimony will be limited to three (3) minutes per person, with no limit to the number of speakers.
- 3. <u>Public Comments on Action Items</u>: Public Comments will be allowed on each action item on the Planning Commission agenda, except for land use decisions for which the public hearing is closed. Verbal comments will be allowed on action items after staff has given their report and have allowed time for initial Commission questions. Comments will be limited to three (3) minutes per person, with a maximum of 15 minutes for all comments on each action item. In practicality, this means no more than five (5) individuals will be allowed to comment verbally. There is no limit on written public comments.

#### PUBLIC HEARING PROCEDURE

The Planning Commission must make its decision based on facts. Prior to the hearing, staff will identify the applicable substantive criteria which have also been listed in the staff report. These are the criteria the Planning Commission must use in making its decision. All testimony and evidence must be directed toward these criteria or other criteria in the Plan or Land Use Regulations which you believe applies to the decision per ORS 197.763 (5). Failure to raise an issue accompanied by statements or evidence sufficient to afford the Planning Commission and parties involved an opportunity to respond to the issue may preclude an appeal based on that issue. Prior to the conclusion of the initial evidentiary hearing, any participant may request more time to present additional evidence, arguments or testimony regarding the application.
